



Unrestricted memorials and tribute gifts totaled \$3,312




Cardinal Alumni donations from the classes of '68, '83, & '88 totaled \$3,760. A five year total from alumni totaled \$19,270.






Mrs. Ethel Glass made a generous estate gift that allowed CBH to take on a large capital investment: 3D Mammography.






A True Community Hospital

Pathways Update



In its third year, the Pathways grant has continued to make an impact on the health and wellness of both Clara Barton Hospital and the Northern Barton County community. Because of the many health and wellness changes made within local businesses and organizations, the Pathways grant has funded: community cooking classes presented by Chef Alli, water filling stations in all Hoisington and Central Plains schools, outdoor exercise equipment on the Clara Barton Hospital property, high visibility crosswalks, enhancements for the Hoisington Middle school greenhouse and outdoor classroom, and many other projects throughout the community in 2018.
